### BREW BABY BACK RIBS

- 1 cup + 1/4 cup TABASCO® Original BBQ Sauce
- 3 cups lager beer
- 1 tsp Kosher salt
- 1/2 tsp black pepper, ground
- 2 cups yellow onion, peeled & sliced
- 5 garlic gloves, peeled & smash
- 1 rack baby back ribs, cut into thirds
